In the last 24 hours, I've heard a lot of questions. "Where's the crime?" "Why name one of the biggest pharmaceutical companies and a major wellness doctor?" "How does this connect to your sister?" But just days into starting the job, everything changed.

My little sister—28 years old—was rushed to the hospital.

She died within 48 hours.

I only took two days off. Because that's all it takes when someone you love is slipping away. And even in that moment—my world crumbling—I was expected to smile and sell supplements like nothing had happened. I didn't want to be alone, so I had my girlfriend visit me a couple times at work. A week later, they fired me. No warning. No write-up. Just done. I asked for my final paycheck, but they refused. So I looked up the company in the Oregon Secretary of State database.

That's when I found out DRVM LLC was dissolved.

Legally dead. Not authorized to operate.

The name on my paychecks shouldn't have been paying anyone.

And that's when I started digging.

The Faces Behind the Paper

DRVM LLC is registered to a single address in Las Vegas.

That same address holds over 100 companies—all shells.

When I cross-referenced the owners, one of the first names that came up was a renowned MD

and weight loss doctor in New Jersey. Co-owner? His father, cofounder of Qunol.

Now go look up Quten Research Institute, Qunol, and QRIB Intermediate Holdings.

You'll see those same names listed as co-founders—.

One address. Dozens of corporations.

Wellness brands, pharmaceutical connections, international links.

And none of it was supposed to be public.

When I was first brought on, I was told the name of the company was "Direct Demo." All of my onboarding documents were branded as "DR DEMO." Then, my training materials came from a group called "MK Marketing Team." But my paychecks came from DRVM LLC. That's four separate names for one job. That's not just confusing—it's intentional. It's designed to make accountability disappear.

When I traced those names, I found that MK Marketing itself was listed as dissolved in the Secretary of State database. And legally, you can't shut down a business and then open another under the same operational model to continue doing what you were doing without exposing yourself to liability. But that's exactly what I found.

Now ask yourself why that structure exists.

Shell Companies Aren't Illegal. What They're Hiding Is.

People have said, "It's normal for companies to share a registered agent address."

Sure. But DRVM wasn't just using the address—it was issuing payroll under a dissolved name. That's illegal in Oregon. And it's not a clerical error.

It's the tip of an entire payroll structure built to obscure who's really profiting off the labor.

This is multi-state payroll fraud.

This affects taxes. This affects labor law.

And if you're a publicly traded company, it affects shareholder disclosures.

And when companies like Sanofi are tied to these operations—whether through shared

People keep asking why I bring up my sister.

Because while I was being paid illegally by a shell company tied to billionaires, she was dying in

One side exploits our pain for profit.

The other side profits by pretending to heal us.

And while I watched her fade away, the people behind these brands were sitting on profits,

protected by fake LLCs and offshore layers.

They don't even use our healthcare system—they fly somewhere else.

That's how little they trust the world they helped build.

Why They Want You Confused

They want you to roll your eyes when I say "shell company."

They want you to think this is too complex to matter.

But every piece ties together.

Our healthcare system.

Our justice system.
