

Reddit Whistleblower Removal Appeal Conversation

Jorden: And can you please describe to me in detail what I violated? I would like to know exactly what I did to get banned. Because everything that I am saying is truthful. That is literally what this sub-Reddit is about. Can you please describe to me what exactly I did?

Reddit: Hello, of course. You were spamming AI crap, and I also noticed that you already had multiple actions against you. You were quick to notice.

Jorden: I'm writing to respectfully appeal this ban. I understand you believe I was "spamming AI crap," but I want to clarify that I've been using AI to assist me in drafting and organizing evidence tied to an active \$15 billion whistleblower arbitration involving corporate fraud. The information I've shared is original, truthful, and directly relevant to the mission of this subreddit.

If there were formatting or frequency issues, I would've appreciated a warning before a permanent ban. I'm not a bot and I'm not spreading misinformation. I'm a real human being trying to expose fraud and share my lived experience, including IRS filings and arbitration evidence in a space that should welcome whistleblowers like me.

Please reconsider this ban, or at least provide a more specific breakdown of the violation so I understand why you are saying this is "AI crap." This is literally me posting. And you are blocking me from posting on the whistleblower group. I would like the breakdown of the violation in detail, please.

Reddit:

I've had not one, but multiple reports from users claiming that your posts should be removed as they are not fit for this subreddit. I checked your posts in this community, and have decided that it would be best to ban you. Every single post you have made has had a considerable percentage of down votes, and it's clear that it's of little to no value to this community. In addition to this, you have had 5 other posts within this community, removed for the same reason. This is the last straw, so you are now permanently banned. Do you have any other questions?

Jorden:

Let me be absolutely clear :

This band is not only excessive, it completely violates the very principal Reddit was built on: open discussion and a free exchange of ideas. You are banning a real whistleblower from starting conversations, not trolling, not lying, not spamming, but presenting verified evidence tied to a \$15 billion arbitration case in a federal filing under IRS review. That should be exactly what this subReddit is for.

You mentioned downvotes, as if it's a legitimate barometer for truth. Since when did public discomfort or controversy means something has "no value?" Whistleblower post aren't supposed to be popular, they're supposed to challenge power. The fact that some people downloaded me says more about them about the content. And you're ignoring the people who upvoted, engaged, messaged me, or quietly watched. That is censorship by mob rule.

You also say I posted multiple times, of course I did. That's what whistleblowers do when the system ignores them. You're punishing persistence. You are silencing a truth- teller for being consistent, too bold, and too difficult to ignore it.

You are not moderating. You are gatekeeping. And trust me, this decision will be acknowledged. On all other platforms. By other people. Because what you just did is exactly what institutions always do when someone gets too close to the truth. They shut the door, label it noise, and hope the story dies. It won't.

Reinstate the account. If you can't handle actual whistleblower content on a whistleblower forum, then change the name of the subreddit - because it clearly doesn't stand for what it claims to anymore.

Reddit:

I will not be unbanning you, but I'm curious as to what more you have to say. But let me say something first, upvotes/down votes are exactly what determine the value of content. By the way, I'm also curious as to what you mean exactly with us moderators gatekeeping rather than moderating? What exactly do we have to gatekeep that will be of benefit to us ? You're a fast typer, I'll give you that.

Jorden:

And now you're cherry-picking how fast I respond? That's your argument?

I've been engaging rapidly and intentionally, not just to defend my posts, but to keep the conversation going. That's what Reddit is supposed to be for: engagement, discussion, and truth-seeking. And let's not pretend this wasn't working, some of my posts were the top posts of the day in your subreddit. Others got buried, sure, but that's how every bold truth moves. It hits resistance first.

The real issue is this: you're gatekeeping across the board. Not just in random communities but in the one

that claims to protect whistleblowers. And what exactly am I doing? Telling the truth. Exposing public documents. Submitting filings to the IRS, DOJ, and arbitration panels. Sharing my lived experience and calling out corporate crime with evidence to back it up.

That's not spam. That's not AI crap. That's

whistleblowing. Exactly what your subreddit pretends to stand for.

So now I have to ask the uncomfortable question, and I'm not the only one thinking it: who's influencing what you're allowing? Are any of the entities I've named - Sanofi, Deepak Chopra, any connected parties, exerting pressure on this platform, directly or indirectly?

Because your behavior makes no sense otherwise.

This will be reported. It's going to every outlet I've

already been talking to and they'll see what happened here. You didn't just ban me. You helped bury a story that's going to be front-page news. And when it is, this thread will still be here showing that even Reddit tried to shut it down.

Reddit:

No, you've misunderstood, I'm simply appreciating how fast of a typer you are. In fact, I'm impressed by it, so much so, that I suspect that you are using AI to tailor your response. But that doesn't matter, and it's besides the point. What do you mean with entites? I need you to explain further, as I'm not quite understanding. Frankly, I'm worried for you, you exhibit strange behavior.

Jorden:

You do realize that you are speaking on behalf of Reddit as a platform, correct? Everything you're saying here is now part of a screenshot trail that shows how Reddit handles whistleblower content and it reflects directly on the organization.

I've been clear from the beginning: I'm using AI to help structure legal filings, documents, and communication because I'm in the middle of a \$15 billion arbitration, with official filings already submitted to the IRS and DOJ. That's not strange.

And the irony? Reddit itself uses AI to manage the platform, for mod tools, spam detection, content ranking. So when you say things like "you're typing too fast," or "this feels off," while dismissing real legal content and calling me unstable, you're not moderating, you're profiling, suppressing, and deflecting.

You asked what I meant by "entities"? Look at the exhibits. I've named Sanofi, Quten Research Institute, Chattem, Deepak Chopra, and a network of shell corporations. These aren't vague claims. They're backed by real evidence, some of which Reddit is now actively burying.

Your tone, condescending, dismissive, and patronizing isn't just inappropriate. It's damaging to Reddit's credibility. You are not just a private citizen in this moment.

You are a moderator representing Reddit's platform, and the way you are speaking to a whistleblower raising legitimate, documented claims is inexcusable. Calling my truth-telling "strange behavior" while acting as a Reddit mod isn't harmless - it's defamatory. You're speaking on behalf of the platform, and framing a whistleblower as unstable is not just irresponsible, it's reckless. I don't know if you realize the liability you're walking into by doubling down like this but it's all being documented. And when this story breaks nationally, which it will. This thread will be part of that timeline.

Again: you are speaking for Reddit right now. And what you're saying is absolutely insane.

Reddit:

Okay... I'm just gonna ignore the fact that you blew everything I said out of proportion, and address something. What do you mean that I'm speaking on behalf of Reddit, and what will happen to me ? Do you think I work for some sort of organisation or something?
I feel like I'm missing a lot of context. I'm worried, not for myself- but for you.
