Hello Bobbi,

On December 12, 2025, shortly after filing the complaint and well before service was completed, I emailed your firm to notify you of the lawsuit and to ask whether Fisher Phillips intended to represent AMJ Services and/or Steven Dickert. I did not receive a response to that inquiry.

As of today, more than 35 days have passed since that notice without any reply. As you are aware, your firm has previously represented AMJ Services in related matters, and prior to this case identified Mr. Dickert in Department of Labor disclosures as having payroll-related knowledge and being reachable through your firm.

Given that history, and the fact that your firm has had actual notice of this case for over a month, I do not believe good cause exists for an extension of time to respond. Granting additional time under these circumstances would be prejudicial to me.

Accordingly, I do not consent to an extension. Please proceed as you see fit.
